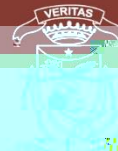

- x The action taken to resolve the complaint
- x The action taken to lessen or prevent the issue from recurring
- x The time taken to resolve the complaint
- x Further action taken if the complaint was not resolved

Complaints Relating to Reportable Conduct

As of 1 July 2017, the Victorian Government legislated for the introduction of a Reportable Conduct Scheme (RCS) to improve how organisations respond to allegations of child abuse and child-related misconduct by employees, volunteers, and contractors.

Legal obligations are imposed on the College Principal to report to the Commission for Child and Young People (CCYP), and investigate allegations of reportable conduct, where those allegations are based on a

Reportable conduct includes the following:

- x Sexual offences against, with or in the presence of a child
- x Sexual misconduct against, with or in the presence of a child
- x Physical violence against, with or in the presence of a child
- x Behaviour that causes significant psychological or emotional harm
- x Significant neglect

Complaints relating to a reportable conduct allegation which meets the requisite threshold, and which involves a Sienna College employee (which amongst others, can include a teacher, principal, volunteer or contractor) must be reported.

Complaints of reportable conduct in relation to an employee (other than a Principal) at Sienna College should be reported to the Principal. In the case of a serious complaint involving the Principal of Sienna College, the Chair of the College Board may be contacted. Sienna College is one of the education ministries of Dominican Education Australia (DEA) and it has an incorporated Board overseeing governance at a local level. Clarify the issue

- x Be clear about the topic or issue to be discussed
- x Be mindful of the need to ascertain all the facts relating to the circumstances of the topic or issue.
- x Think about what an acceptable outcome would be
- x Check and observe the Sienna College complaints handling policy
